Permission is based on prior satisfactory fulfillment of the 'Criteria for Recognition as Fellow Member Trainer IANLP'.

By endorsing the conditions seth forth in this document, the undersigned acknowledges the following rights and obligations:

## General Rights and Obligations

For the duration of this use agreement, the signer is authorized to use the title "Fellow Member Trainer IANLP".

Signer is authorized to use the digital IANLP-logo for the purposes of promoting the goals of the IANLP, and to use the logo for curricula that conform to the standards of the IANLP. The logo in its entire present form is not be altered in any way.

Signer is authorized to use the term "Fellow Member Trainer IANLP" in his/her literature and any other printed or electronic media.

Signer will submit any and all documents required by IANLP to examine adherence of these conditions set forth in this agreement.

Signer will provide IANLP with statistical data of trainings and participants that might be used to promote the goals of the IANLP, provided that IANLP requests data in a fashion that protects the privacy rights of the

individuals involved and will conform any state laws applicable.

Signer agrees to implement any new requirements of curricula that may be communicated to him/her in the course of the life-time of this agreement.

This use agreement is limited to a duration of five (5) years. Extensions of five (5) years will be granted, upon evidence being presented that regular Quality Development Meeting has been conducted according to the regulations of the Quality Assurance System of the IANLP.

Signer of Use Agreement (Level 50) is authorized to certify in the name of the IANLP and to use seal of the IANLP for NLP Practitioner trainings only.

If a Use Agreement has been cancelled, it can be regained after having participated as an assisting person to a complete Master- and a complete Practitionertraining.

Special Obligations	Initial
Signer will promote and foster the goals of the IANLP. He/She has read and signed the Code of Ethics. In particular he/she will sustain from offering and/or promoting and/or participating in any nlp trainings labeled 'practitioner' and/or 'master' and/or 'trainer' that do not fulfill or exceed the standards set forth by the IANLP.	
Signer will provide data for all IANLP curricula trainings that she/he is participating in. To this purpose the IANLP informs the signer which data shall be submitted. If several FMT's are participating in a given training, this data has to be submitted in one copy only.	
Signer will use unique IANLP Certificate Numbers and seal of the IANLP on certificates only when the curricula adheres to the IANLP guidelines and the receiver of said certificate has completely fulfilled the curricular requirements.	
Signer keeps track of the IANLP Certificate Numbers used on certificates as follows: Firstname, Name of Student; Email of Student; Level of Certificate, IANLP Certificate Number, Date of Issuance of Certificate. Whenever a batch of IANLP Certificate Numbers has been completely used copy of this information is sent to the office of the IANLP.	

Signer will notify IANLP of any change of address or electronic address (Email). Communication by IANLP to the last known address or Email address shall be regarded of having been dutifully delivered.							
Digital advertising (webpage, social media) relating to an IANLP curriculum must provide a link to the IANLP website.							
All advertising relating to an IANLP curriculum must provide clear information on complete duration of the training in days and hours as well as on being a face-to-face live on-site training.							
Regular, periodic Supervision (at least 6 sessions per year or at least 1 session per 10 days of conducting NLP Practitioner trainings, whichever is the higher number) with an FMT IANLP and written reflexions on personal learnings. This provision applies for the first three years after signing this use agreement.

Holder of Use Agreement (Level 100) is authorized to certify and use original sticker seals of the IANLP for certificates NLP Practitioner IANLP, Certificate in Advanced NLP IANLP, NLP Master IANLP and Certificate of Proficiency in NLP IANLP.							
Holder of Use Agreement (Level 100) who fulfills all qualifications as described in the respective curriculum may apply for certifying NLP Trainer IANLP and/or Coach IANLP.							
After upgrading to level 100 the use agreement will be extended regularly by further five (5) years upon evidence being presented that regular Quality Development Meeting has been conducted according to the regulations of the Quality Assurance System of the IANLP.							
Signer may cancel this Use Agreement at any time and without any notice. Use Agreement can be cancelled by IANLP if the signee violates letter and/or spirit of the above conditions.  If the use agreement is cancelled by either party, signer obligates him/herself to return all sticker seals and all unique IANLP certificate numbers to the IANLP. Financial refund will be granted. Signee hereby renunciates any and all no liability claims and/or any other claims, on whatever basis, against the IANLP and its representatives.
